The commission held 10 in person meetings and four virtual meetings during the year.

The commission had many accomplishments over the past year, including implementing the Milk Quality and Premise Penalty Order to ensure the quality of milk in the province.

Furthermore, Research and Productivity Council purchased a Bactoscan machine for bacteria testing. With Bactoscan, the commission was able to increase bacteria testing on raw milk samples from once a month to once a week.

Mandate

New Brunswick Farm Products Commission is a supervisory body appointed by the Lieutenant-Governor in Council empowered to carry out the provisions of the *Natural Products Act* and any regulations and orders under the Act.

Committees and subcommittees

Subcommittee for establishing Boards and Agencies: The subcommittee was responsible for creating a standard operating procedure for establishing any new Boards or Agencies under the *Natural Products Act.*

During the 2022-2023 year, this subcommittee created a standard operating procedure and an application for any organization applying to become a Board or Agency. The subcommittee received one application during this year.

Legislation, policies, and by-laws

The Commission is governed by the Natural Products Act.

- Conducted annual reviews of two agencies (Bleuets NB Blueberries, Canneberges NB Cranberries) and all eight commodity boards (Potatoes New Brunswick, Apple Growers of New Brunswick, Chicken Farmers of New Brunswick, Egg Farmers of New Brunswick, Turkey Farmers of New Brunswick, Dairy Farmers of New Brunswick, New Brunswick Cattle Producers, Pork NB Porc)
- Staff of the commission attended the annual and regional meetings of the producer organizations formed under the *Natural Products Act*
- Staff of the commission attended the national meeting for Canadian Milk Supply Management Committee (CMSMC), Dairy Industry Council, Canadian Dairy Commission Annual Public Meeting, Joint P5 Supervisory Body and Western Milk Pool Coordinating Committee, CMSMC Secretariat, Technical Committee of the P10 Signatories, National Association of Agri-Food Supervisory Agencies, International Association of Milk Control Agencies, Farm Products Council of Canada Meeting, and International Dairy Federation
- Reviewed wholesale and retail prices of fluid milk products in the province and issued increases in September and February
- Approved 5 new orders (2022-02 Wholesale and Retail Pricing Order, 2022-04 Milk Quality and Premise Penalty Order, 2022-06 Milk Quality and Premise Penalty Order, 2023-01 Wholesale and Retail Pricing, Order 2023-02 Lab Pasteurization Order)
