



Nursing Home Monitoring Inspection Report

Pursuant to section 25(3) of the *Nursing Homes Act*, “an inspector may at any reasonable time enter a nursing home to make an inspection to ensure that the provisions of this Act and the regulations are being complied with.”

Inspections are conducted to ensure the nursing homes comply with regulatory requirements. Besides the annual inspection, if there are reasons to believe that there are issues or concerns related to the health or safety of residents, other visits may be made at any time or follow up to evaluate the situation and take appropriate action.
