The personal information collected on this application form is being collected for the Premises Identification Program of the New Brunswick Department of Agriculture, Aquaculture and Fisheries and will be used for one or more of the following purposes:

- (a) detecting, preventing, controlling, managing and eliminating disease;
- (b) analyzing the geographical distribution of disease and the epidemiology of disease outbreaks;
- (c) conducting assessments and models to prevent disease risk;
- (d) tracking the movement of animals from premises to premises;
- (e) protecting animal health and human health;
- (f) emergency planning;
- (g) eliminating disease barriers to market access;
- (h) verifying the accuracy of information collected on the application form.

The information may be released to the following persons or entities:

- (a) a department, branch, office or agency of the government of New Brunswick;
- (b) the Government of Canada or a municipal, provincial or foreign government or an agency of such a government, including employees thereof whose duties include:
 - i. protecting the public health
 - ii. monitoring or reporting on the safety of agricultural inputs, foods, livestock or livestock products, or
 - iii. monitoring or reporting on the biological, chemical and physical integrity of agricultural inputs, food, livestock or livestock products;
