

## **Mandatory Training** **for individuals purchasing fish from fishers at the wharf**

As of April 1, 2014, all fish buying licence holders must ensure that at least one individual per buying station at the wharf has completed a training program on storage, handling, holding and transporting of fish. That individual must also carry a photo identification card.

The services of **Mr. Germain Landry\***, Food Process Specialist, have been secured to develop and deliver the 3.5 hours mandatory training program.

- Training programs are held at the regional offices of the Department of Agriculture, Aquaculture and Fisheries in Caraquet, Bouctouche and St. George.
- Training sessions are offered in English and French.
- The cost per participant is \$90 plus applicable taxes (\$101.70).  
The cost includes take-home materials and the training certificate which is valid for 5 years from the date of issuance.
- Payment, by cash or cheque, can be made on the day of the training.
- Dates of the training sessions will be determined based on registrations received and you will be contacted by Germain to confirm your availability at that time.

\* **Germain Landry** has completed a Bachelor Degree in Biology and a Master's Degree in Food Science at the Université Laval in Quebec City. He has worked as a Quality Control Person for a seafood processor for 5 years and as a food process specialist for RPC the Research and Productivity Council for 21 years, where he worked with the seafood industry on a number of processing, harvesting and quality improvement projects.

In 2012, he founded a consulting firm, **Consultation Germain Landry Consulting** and divides his time between performing quality third-party audits (Safe Quality Food, Food Safety and Quality System) food process consulting and delivering training. He has provided training programs for plant workers, supervisors and Quality Assurance Personnel on quality, Hazard Analysis Critical Control Point (HACCP) program and food microbiology.
