1 *Section 2 of the English version of New Brunswick Regulation 2003-54 under the Natural Products Act is amended in the definition “Board” by striking out “New Brunswick Egg Producers” and substituting “Egg Farmers of New Brunswick”.*

2 *Section 7 of the English version of the Regulation is amended*

(a) by repealing subsection (1) and substituting the following:

7(1) The name of the Board is changed from the New Brunswick Egg Producers to the Egg Farmers of New Brunswick.

(b) by repealing subsection (2) and substituting the following:

7(2) A reference to the New Brunswick Egg Marketing Board or to the New Brunswick Egg Producers in any other regulation or in an Act, rule, order, by-law, agreement or other instrument or document is deemed to be a reference to the Egg Farmers of New Brunswick unless the context otherwise requires.

(c) by repealing subsection (3) and substituting the following:

7(3) An order, rule, by-law, resolution, decision, direction, determination or agreement made by the New

3 This Regulation comes into force on October 1, 2015.
