Special events

The conference will feature several book launches (details below), workshops, and film/documentary screenings as part of the 5th edition of the <u>uOttawa Human Rights Film Festival</u>.

Book launches:

- Professors Delphine Nakache and Yves Le Bouthillier will introduce their book "Le droit de la citoyenneté au Canada" (Citizenship Law in Canada, forthcoming English publication) in a special session. It is the first major legal study tracing the transformations of Canadian citizenship laws and regulations and the rights of Canadian citizens.
- The Canadian Section of the International Commission of Jurists will convene a special panel introducing its book on the rule of law and Canada, 150 Years after Confederation, which compiles thought-provoking essays by legal experts from across Canada on the rule of law and human rights.
- The Human Rights Research and Education Centre will launch the 2015 edition of the Canadian Human Rights Yearbook, originally published between 1983 and 1992. It is an authoritative reference on key developments in human rights in Canada and global developments relevant to Canada.

Logistics

All meals provided by the conference will be hosted at the University Square (in front of the Faculty of Social Sciences Building, 120 University Private). Plenary sessions will take place under a comfortable tent situated in University Square. Participants will enjoy ample space to network and meet between sessions.

Concurrent sessions will be held in the Fauteux Faculty of Law Building – 57 Louis Pasteur Private, a 3 minute walk from the University Square.
