

# Information for Alcoholic Beverage Manufacturers in New Brunswick

## **LIN: 0513**

To obtain a licence for manufacturing alcoholic beverages in this province, the manufacturing premises must be located in New Brunswick. Licences must be obtained from the Provincial Department of Justice and Public Safety, Gaming Control and Licensing Services. The fees and the licence types are listed below. The licence is renewable by March 31st each year with the payment of the licence fee.

### **Distillery Licence**

The licence fee is \$100 where 75,000 litres of liquor or less are manufactured in the Province per year and \$2,500 where more than 75,000 litres of liquor are manufactured per year.

### **Winery (Farm Wine Producer) Licence**

The licence fee is \$100 where 100,000 litres of wine or less are manufactured in the Province per year and \$2,500 where more than 100,000 litres of wine are manufactured per year.

### **Brewery (Micro Brewery) Licence**

The licence fee is \$100 where 500,000 litres of beer or less are manufactured in the Province per year and \$2,500 where more than 500,000 litres of beer are manufactured per year.

### **In-House Brewery Licence**

To qualify, an applicant must be the holder of, or apply for a Special Facility, Lounge or Dining-Room Licence.

The licence fee for an In-House Brewery is \$750.

A distillery or winery **may be required** to obtain a Federal Licence issued by Canada Revenue Agency. A brewery in New Brunswick must obtain a Federal Licence before a Brewery Licence will be issued. To obtain information and/or an application, contact:
