### **FOREWORD**

The Regional Emergency Response Plan is issued in accordance with Chapter E-7.1 Emergency Measures Act assented to May 13, 2011. It is effective upon receipt.

This document replaces the any pervious Regional or District Emergency Action Plan currently in use.

This plan will provide the basis for the regional response to any emergency within the Province of New Brunswick. This plan is complimentary and does not supersede Municipal plans. It is to be read in conjunction for proper context.

The members of the Regional Emergency Action Committee, the members of the Regional Service Commission, Mayors and Council members for any municipality, rural municipality and any representative of a Local Service District and any interested agency involved in emergency planning are invited to comment on the plan or to provide suggestions for amendment.

INTRODUCTION

1. The aim of the plan is to provide a prompt, coordinated and effective response to emergencies by the Government of New Brunswick, its agencies and departments and by the various regional and local government authorities, municipalities and non-governmental agencies at a regional level.
2. This plan is issued by the Minister of Justice and Public Safety, under the authority of the Emergency Measures Act.
3. The Regional Emergency Response Plan may be cited as the Regional Emergency Response Plan and describes a level of preparation, planning and response situated between the Provincial All Hazards Plan and Municipal Emergency Response Plans.
4. Chapter E-7.1 Emergency Measures Act assented to on May 13, 2011 is the key piece of legislation upon which the Emergency Measures Plan is based. It provides definitions, makes the Minister of Justice Public Safety responsible for the administration of the Act, establishes the New Brunswick Emergency Measures Organization (EMO), provides guidelines and responsibility for emergency planning, and outlines States of Emergency, Disaster Relief Fund and Liability for Damages.
5. Regulation 84-7 under the Emergency Measures Act (O.C. 84-29) filed on January 23, 1984 details responsibilities for regional government departments and agencies. Regulation 83-71 under the Emergency Measures Act (O.C. 83-377) filed on April 29, 1983, as amended by Regulation 90-166 filed on December 14, 1990 outlines the disaster assistance available to municipalities. This act and these regulations should be read as background to this plan.
6. The plan is designed to provide direction and guidance for dealing with emergencies ranging from a single regional departmental response to a fully coordinated, collective response by all regional departments, supported by the provincial government. It may be implemented in whole or in part, depending on the situation.

Part 1. General Information	
1.1	<b><u>Background</u></b>
1.1.1	<p>Emergency situations, at times, generate confusion with respect to roles and responsibilities and jurisdictions. By means of the following Regional Emergency Response Plan, needless duplication of effort or waste of resources will be eliminated. The plan was developed using the Incident Command System, and was refined with the CSA Z1600-14 Emergency and Continuity Management Program.</p> <p>The plan is divided into three colour coded parts:</p> <ul style="list-style-type: none"> <li>a. Part 1 (<b>Green</b>): General Information;</li> <li>b. Part 2 (<b>Yellow</b>): Regional Response/Actions; and</li> <li>c. Part 3 (<b>Red</b>): Roles and Responsibilities during Activation.</li> </ul>
1.2	<b><u>Areas of Influence and Interest</u></b>
1.2.1	<p>In the event of an emergency, delineating areas of influence and interest is critical to managing and coordinating, to limit disruption, and to ensure that only the resources required during the emergency are used. As defined:</p> <ul style="list-style-type: none"> <li>a. The <b>Area of Influence</b> is tied to jurisdictions and the requisite authorities to commit the necessary resources in order to influence the outcome of an emergency. As such, the Area of Influence is defined by geography, connectivity and time.</li> <li>b. The <b>Area of Interest</b> is defined by actual or potential events, normally situated outside the area of influence, which may impact the region.</li> </ul>
1.3	<b><u>Phases of an Emergency Operation</u></b>
1.3.1	<p>An emergency will normally graduate through four distinct phases. They are:</p> <ul style="list-style-type: none"> <li>a. The <b>Warning Phase</b> consists of actions taken to counter and curtail the effects of the incident. These include alerting the public, local and Regional authorities, and preparing resources.</li> <li>b. The <b>Impact Phase</b> refers to the event itself.</li> <li>c. The <b>Response Phase</b>, which may overlap the Impact Phase, covers the period during which the emergency is brought under control.</li> <li>d. The <b>Recovery Phase</b> is the clean-up period, used to return the affected communities to normal.</li> </ul>
1.4	<b><u>Graduated Response</u></b>
1.4.1	<p>A graduated response allows for the control and coordination of resources assigned to deal with an emergency. It allows for the use of only those resources, human and material, necessary to meet the requirements of that incident, and speaks to attempting to deal with an emergency at the lowest level practicable. In keeping with this concept, the response at the Regional level will be tailored to meet the circumstances of a given emergency.</p>
1.5	<b><u>Levels of Responsibility</u></b>
1.5.1	<p>The Regional level of emergency management falls into a graduating system of increased responsibility, areas of influence and interest that are based on the different levels of government authority in the Province of New Brunswick as follows:</p>

	<ul style="list-style-type: none"> <li>a. <b>Individual</b> – Individuals are responsible for themselves and their immediate family and includes household and neighbourhood preparations such as the <a href="#">72 Hour Emergency Preparedness Kits</a></li> <li>b. <b>Municipal/Local Authority Response</b> – Municipal level resources managed by local Mayors and Councils, and Local Service Managers.</li> <li>c. <b>Regional</b> – Regional level resources coordinated by the NB EMO Regional Emergency Management Coordinators (REMC) and Regional Emergency Action Committees (REAC). This includes: <ul style="list-style-type: none"> <li>(1) Developing and implementing Regional plans and procedures for an integrated Regional response to emergencies.</li> <li>(2) Assuming direction and control as authorized by the Director of NB EMO: <ul style="list-style-type: none"> <li>(a) Only when municipal or local authority does not exist;</li> <li>(b) Only when municipal or local authority requests and the Minister of Justice and Public Safety authorizes direct action;</li> <li>(c) Only when the event is of such magnitude that it is clearly beyond the capability of local authorities; and</li> <li>(d) Only when the action required in dealing with the emergency rests with the province or a department, e.g. large scale health or environmental emergency.</li> </ul> </li> </ul> </li> <li>d. <b>Provincial</b> – Government of New Brunswick resources managed by the Department of Justice and Public Safety (JPS) and NB EMO.</li> <li>e. <b>National</b> – Government of Canada resources managed by Public Safety Canada.</li> </ul>
1.6	<p><a href="#">Levels of Response</a></p>
1.6.1	<p>A graduated response will focus efforts to ensure the lives and welfare and property of citizens and the environment are at the forefront of response actions. As such, the following levels of response will be used:</p> <ul style="list-style-type: none"> <li>a. <b>Individual Response</b> – Assist municipal and local authorities in identifying the emergency;</li> <li>b. <b>Municipal or Local Authority Response</b> – Municipal authorities are responsible for dealing with the emergency. Local Service Managers will monitor, and if required, seek support from the REMC.</li> <li>c. <b>Regional Response</b> - When the capacity of the local authority is exceeded, or is likely to be exceeded, a Regional response is activated and involves support provided from the neighbouring municipalities through formal or informal mutual aid arrangements and from Regional resources through the REMC.</li> <li>d. <b>Provincial Response</b> - When a Regional response is insufficient, the REMC will request assistance from the Provincial Emergency Action Committee (PEAC).</li> <li>d. <b>National Response</b> - If additional response is required, federal support and assistance will be arranged by the PEAC.</li> </ul>

1.7	<b><u>Authority – Minister of Justice and Public Safety</u></b>
1.7.1	<p>In accordance with the Emergency Measures Act, the Minister of Justice and Public Safety is responsible for emergency declarations, executive coordination and the exercising of assigned executive powers. The Minister advises the Premier and Executive Council on emergency management and security matters, and coordinates the assistance provided by:</p> <ul style="list-style-type: none"><li>a. Department of Justice and Public Safety, Deputy Minister;</li><li>b. Police, Fire and Emergency Services Division, Assistant Deputy Minister;</li><li>c. Executive Director Emergency Services;</li><li>d. Director Office of the Provincial Security Advisor; and</li><li>e. Director Emergency Measures Organization.</li></ul> <p>The Minister shall coordinate emergency measures plans within the Province and may delegate powers vested in him by or under the Emergency Measures Act. Subject to the approval of the Lieutenant-Governor in Council, the Minister may:</p> <ul style="list-style-type: none"><li>a. Enter into agreements with the Government of Canada (GoC), the government of a province or territory of Canada or the government of a state of the United States of America, or an agent of any of them, with respect to emergency measures plans;</li><li>b. Enter into agreements with the GoC and the Workplace Health, Safety and Compensation Commission for the administration and payment of compensation benefits to persons engaged in training or carrying out duties related to a state of emergency or a state of local emergency; and</li><li>c. Acquire by purchase or lease of real and personal property for the purposes of administering the NB EMO.</li></ul> <p>The Minister may: <b><u>Emergency Measures Act</u></b></p> <ul style="list-style-type: none"><li>a. Divide the Province into districts and sub-districts for the purposes of the Emergency Measures Act;</li><li>b. After consultation with a municipality, designate the boundaries of the municipality to include areas adjacent thereto;</li><li>c. Require municipalities to prepare emergency measures plans, including mutual assistance programs, and to submit them to the Emergency Measures Organization for review for adequacy and integration with the Regional Emergency Response Plans;</li><li>d. Establish procedures for the prompt and efficient implementation of emergency measures plans; and</li><li>e. Require any person to develop emergency measures plans in conjunction with the Emergency Measures Organization or the municipalities to remedy or alleviate any hazard to persons, property or the environment that is or that may be created:<ul style="list-style-type: none"><li>1. By a condition that exists or may exist on that person's property;</li><li>2. By that person's use of property;</li><li>3. An operation in which that person is or may be engaged; or</li><li>4. By a process that that person is or may be utilizing.</li></ul></li></ul>

1.8	<b><u>States of Emergency:</u></b>
1.8.1	<p>The Minister of Justice and Public Safety may at any time, when satisfied that an emergency exists or may exist, declare a <i>state of emergency</i> in respect to all or any area of the Province for a maximum of <b>14 days</b>. The mayor of a municipality may, under similar circumstances, declare a State Of Local Emergency (<b>SOLE</b>) in respect of that municipality or part of that community for a maximum of <b>7 days</b>.</p> <p>When a state of emergency or a state of local emergency has been declared under this Act, the Minister or the municipality, as the case may be, shall immediately cause the details of the declaration to be communicated or published by those means that the Minister or municipality considers the most likely to make the contents of the declaration known to the civil population of the area affected.</p> <p>On a state of emergency being declared in respect to the Province or an area of the Province, or on a state of local emergency being declared in respect to a municipality or an area of a municipality, the Minister may, during the state of emergency, in respect of the Province or an area of the Province, or the municipality may, during the state of local emergency, in respect of the municipality or an area of the municipality, as the case may be, do everything necessary for the protection of property, the environment and the health or safety of persons therein, including:</p> <ul style="list-style-type: none"><li>a. To cause an emergency measures plan to be implemented;</li><li>b. To acquire or utilize or cause the acquisition or utilization of any personal property by confiscation or by any means considered necessary;</li><li>c. To authorize or require any person to render the aid that the person is competent to provide;</li><li>d. To control or prohibit travel to or from any area or on any road, street or highway;</li><li>e. To provide for the maintenance and restoration of essential facilities, the distribution of essential supplies and the maintenance and coordination of emergency medical, social and other essential services;</li><li>f. To cause the evacuation of persons and the removal of livestock and personal property threatened by a disaster or emergency, and make arrangements for the adequate care and protection of them;</li><li>g. To authorize any person properly identified as authorized by the Minister, by the Emergency Measures Organization or by the municipal emergency measures organization to enter into any building or on any land without warrant;</li><li>h. To cause the demolition or removal of any building, structure, tree or crop if the demolition or removal is necessary or advisable for the purposes of reaching the scene of a disaster, of attempting to forestall its occurrence or of combatting its progress;</li><li>i. To procure or fix prices for food, clothing, fuel, equipment, medical or other essential supplies and the use of property, services, resources or equipment; and</li><li>j. To order the assistance, with or without remuneration, of persons needed to carry out the provisions mentioned in this section;</li></ul> <p>And in addition, the Minister may authorize or require a municipality to cause an emergency measures plan for the municipality, or any part of the municipality, to be implemented.</p>

<b>1.9</b>	<p><b><u>The Regional Emergency Action Committee (REAC)</u></b></p> <p>When a substantial Regional involvement is indicated or when there is a need to coordinate a Regional response, the REAC will be activated.</p> <p>The REAC managed by the REMC or his/her representative, is comprised of representatives of those Regional departments detailed in Regulation 84-7 under the NB EMO Act. The precise departmental representation in the REAC will depend on the nature and scope of the event. It may also include federal or other agency representatives as necessary.</p> <p>The REAC consists of departmental representatives, who staff the departmental desks in the REOC. They will provide their department's input to the Committee and will keep their department informed. Those Regional departments which normally do not provide representatives in the REAC may be called upon for advice or resources.</p> <p>The REAC may be assembled by the Director NB EMO or designate at any time before or during an emergency for the purpose of:</p> <ol style="list-style-type: none"> <li>a. Assessing a potential emergency situation with specific focus towards: <ol style="list-style-type: none"> <li>1. Aviation Incident;</li> <li>2. Rail Incident;</li> <li>3. Industrial Incident (includes Pipeline);</li> <li>4. Transportation Incident (includes Marine);</li> <li>5. Engineering Failures (Bridges, Structural or Building Collapses);</li> <li>6. Rural Fire;</li> <li>7. Flash Flood;</li> <li>8. Civil Disorder (includes Explosion or Active Shooter);</li> <li>9. All Weather Events;</li> <li>10. Power Outages; and</li> <li>11. Any other emergency as necessary.</li> </ol> </li> <li>b. Preparing or reviewing contingency plans and procedures;</li> <li>c. Considering the deployment of resources and Incident Commanders to an emergency;</li> <li>d. Monitoring operations, provide direction to departments, regions, Incident Commanders;</li> <li>e. Providing situation updates and making recommendations to the Director; and</li> <li>f. Referring major problems for resolution to the Director and implementing the direction received.</li> </ol>
<b>1.10</b>	<p><b><u>Regional Emergency Operations Centres (REOCs)</u></b></p>
<b>1.10.1</b>	<p>When a substantial Regional response is required, the REAC will be activated and will report to their assigned Regional Emergency Operations Centres (REOCs). The REOCs contain the necessary working accommodation and communications that enable proper coordination. In addition to the REOCs, departmental operation centres, or other designated facilities may be established to control and direct departmental operations.</p> <p>When required, the following activation levels will be used to notify members of the REAC. The alert will come from the REMC or LSM or designated alternate.</p>

	<p>The levels are:</p> <ul style="list-style-type: none"> <li>a. Level 1 (<b>Green</b>): Enhanced Monitoring: Continuous monitoring by all REAC members of an emergency situation that may require immediate Regional assistance.</li> <li>b. Level 2 (<b>Yellow</b>): Partial Activation: Once notified, selected REAC members may be called in to assist in supporting ongoing efforts towards an emergency.</li> <li>e. Level 3 (<b>Red</b>): Full Activation: All REAC members are to report into the REOC.</li> </ul>
1.11	<p><b><u>Municipal Emergency Operations</u></b></p>
1.11.1	<p>In an emergency the response structure will be based on the Municipal EMO supported by mutual aid arrangements, assisted by the REMC as required.</p> <p>Municipal authorities are responsible for:</p> <ul style="list-style-type: none"> <li>a. Implementing local emergency plans and conducting emergency operations using the resources available to the municipality;</li> <li>b. Informing the REMC promptly about a local emergency;</li> <li>c. Requesting assistance from other municipalities in accordance with mutual aid agreements; and</li> <li>d. Requesting assistance from the provincial government through the REMC in accordance with established emergency response procedures.</li> </ul> <p>If the emergency escalates to the point where further powers are required, the Municipal EM Coordinator may recommend to mayor and council that a SOLE be declared in accordance with the Emergency Measures Act (R.S.N.B. 2011, c. 147), and municipal by-law. <b>Note: Once signed, the municipality must inform NB EMO immediately.</b></p>
1.12	<p><b><u>Local Service Districts (LSDs)</u></b></p>
1.12.1	<p>The Department of Environment and Local Government (DELG) Local Service Managers (LSMs) are members of the REAC. They will monitor, and if necessary coordinate with the REMC for all emergency planning and operations for LSDs.</p>
1.13	<p><b><u>Regional Emergency Operations</u></b></p>
1.13.1	<p>The Regional Emergency Management is designed to provide a more robust and responsive Emergency Management capability across the province. This capability compliments the Regionalization of government services allowing municipalities, rural communities and LSDs to plan and coordinate on a Regional basis in order to enable a more effective response to emergency situations.</p> <p>The Regional emergency management is situated between the municipal and provincial levels of emergency management. It allows for the development of Regional emergency protocols which may specify mutual assistance agreements between communities, provide assistance in developing and maintaining local emergency measures plans, and facilitating training initiatives for Regional and inter-Regional emergency responses.</p> <p>The twelve Regional Service Commission (RSCs) regions of DELG have been designated NB EMO Regions.</p>

	<p>The REMC is responsible to the Director of NB EMO for emergency:</p> <ul style="list-style-type: none"> <li>a. <b>Planning:</b> <ul style="list-style-type: none"> <li>1. Develop and maintain a Regional Emergency Response Plan;</li> <li>2. Establish an REOC for the control and coordination of emergency operations;</li> </ul> </li> <li>b. <b>Operations:</b> <ul style="list-style-type: none"> <li>1. Establish and maintain situational awareness with the RSCs, LSMs, municipal officials and all responding agencies;</li> <li>2. Maintain contact with NB EMO or the PEAC, if activated;</li> <li>3. Refer unresolved matters to NB EMO for resolution and direction;</li> <li>4. Advise and assist local authorities in the implementation of their emergency response plans; and</li> <li>5. Coordinate the Regional Emergency Response Plan.</li> </ul> </li> </ul>
1.14	<p><a href="#"><u>Initiation of a Regional Response</u></a></p>
1.14.1	<p>NB EMO is available <b>24</b> hours a day, <b>365</b> days a year. As part of their normal duties, the NB EMO staff will monitor events that may impact New Brunswick.</p> <p>Notification of an emergency, or potential emergency, can be received from several sources. Such as:</p> <ul style="list-style-type: none"> <li>a. Local authority can alert the REMC, who will in turn alert NB EMO.</li> <li>b. Regional department can receive the initial notification from its field staff, and should promptly inform NB EMO.</li> <li>c. First responders may contact the NB EMO directly through its 24 hour emergency number (<b>Phone 1-800-561-4034</b>).</li> <li>d. NB EMO may receive an alert from a federal government agency or direct from international sources.</li> </ul> <p>In all circumstances, the NB EMO staff can provide advice or, if appropriate, initiate the Regional notification system. Please refer to the following documents:</p> <p><a href="#"><u>Critical Infrastructure / Regional Activation Timeline</u></a></p>
1.15	<p><a href="#"><u>Emergency Communications</u></a></p>
1.15.1	<p>Emergency Communications consist of delivering operational messages within the context of Emergency Operations Centers, responding agencies and site management utilizing various technical means of communications. It also describes communicating public information, instructions, updates and if necessary, emergency declarations to the general public.</p> <ul style="list-style-type: none"> <li>a. <b>Operational Communications:</b> Many routine communications will be done using the most efficient means available, with due regard to maintaining records of decisions and actions taken. Often this will consist of e-mails which can be filed for later retrieval. Depending on the nature of the emergency or immediacy of the communication, other means may be required:</li> </ul>

	<ol style="list-style-type: none"> <li>1. Trunked Mobile Radio (TMR), when fully implemented, will allow all agencies to communicate verbally via a mutual aid channel designated by Provincial Mobile Communications Center (PMCC). Such a channel should be requested by the initial responding agency and maintained for the duration of the event, with additional channels designated as necessary. All communication on this system should be recorded by PMCC.</li> <li>2. Amateur Radio Emergency Service (ARES), also known as “ham” radio. When all other forms of communication are unavailable, EOCs may call upon this service for short or long distance message transmission. Ham operators are trained to record transmission logs and message content.</li> <li>3. Software such as SENTINEL, EVERBRIDGE, CRYISIS, MASAS, LINK and others may be used to connect EOCs to simultaneously exchange information such as event logs, imagery and detailed maps. When available, these should be linked to ensure maximum awareness between various agencies contributing to the response. Data must be captured and recorded at scheduled intervals and during significant events.</li> <li>4. Telephone; traditional land lines and cellular communications remain the most popular method of rapidly connecting two individuals. When used for teleconferencing, large groups can be briefed simultaneously. Vulnerabilities include downed lines or cell towers, loss of voice quality, restriction of information sharing and poor record keeping.</li> </ol> <p>b. <b>Public Information:</b> Communicating information to the general public in a clear and timely manner is a crucial element of managing an incident. Consideration should be given during the warning phase, if possible. Informing the public of registration and warming centers, evacuation plans and recovery operations will greatly assist in reducing anxiety. Many methods may be utilized.</p> <ol style="list-style-type: none"> <li>1. ALERT READY is the national system to be used by a provincial authority in cases of serious threat to life and safety. It employs interruptions to the public broadcasting systems on radio and television. Eventually, it may also have the capability to target specific cell towers for customized messaging.</li> <li>2. Public messaging via social media is the most widespread and effective means of distributing information as it increases coverage as recipients share with friends. Various media such as e-mail, Twitter, Facebook and others should be used. In order to achieve maximum efficiency, a single source of verified information should be utilized to avoid conflicts. Frequent and timely updates must be maintained in order to prevent disinformation.</li> <li>3. Media conferences by persons in authority. Care in avoiding impromptu statements and the selection of a known and credible person of authority in the affected community is recommended.</li> <li>4. Self-registry by citizens on municipal warning systems such as SENTINEL and others allows for targeted messages over a wide spectrum of events.</li> <li>5. Posting written directives at warming shelters, municipal and public offices in addition to pre-advising citizens of where and how to seek information during emergencies will go a long way to ensuring smooth communications during an incident.</li> </ol>
1.16	<b><u>Non-Governmental Organizations (NGOs) / Volunteer Agencies</u></b>
1.16.1	An effective emergency response will depend to a large degree on the full use of all resources in the community. The province and most municipalities have a number of social services agencies, clubs, organizations and other civic minded groups who can provide a wide range of skills, people and equipment.

Many volunteer agencies are prepared to offer their services in an emergency. These volunteers should be encouraged. Where appropriate a memorandum of understanding or a letter of intent should be prepared and signed by municipal authorities and the volunteer agency.

These memoranda or letters should specify the forms of assistance to be provided and the arrangements, including financial, for its provision. These formal arrangements are useful to ensure coordination of volunteer activity. Procedures for obtaining and rendering assistance are to be set out in municipal emergency plans. Volunteer agencies will, depending on their assigned task, be allotted to the appropriate emergency response departments who will control and coordinate the volunteer agency response.

**1.17**      [Mutual Aid and Request for Assistance \(RFA\)](#)

A municipality or region may become overwhelmed at any time during an emergency. As a consequence, additional resources from neighbouring jurisdictions may be required. Municipalities/LSDs are encouraged to establish these mutual aid arrangements with other jurisdictions and to institute an arrangement with local volunteer agencies.

**1.17.1**      However, when it is anticipated that quick access to additional resources are required, then a Request Force Assistance (RFA) will be submitted to the REMC. The RFA will come from an authorized municipal/LSD representative.

Requests for assistance from other Government of Canada departments, such as the Canadian Armed Forces (CAF) will be coordinated by NB EMO who will determine if the request is required.

**1.18**      [Termination of Operations / Recovery](#)

**1.18.1**      The Regional emergency response will continue until Regional assistance, direction and coordination are no longer required and the operation is terminated. The gradual reduction of departmental staff and the withdrawal of resources may begin before termination, but it must be done on a planned and coordinated basis.

If communities experienced significant impacts due to the emergency, there may be a need to support and/or supplement personal, family, and community structures that may have been damaged or disrupted.

**1.18.2**      The effects of an emergency depend directly on the type, severity, and duration of the event. Some common effects of an emergency include:

- a. **Physical Effects:**
  - (1) Damage to buildings, commercial structures, and community facilities;
  - (2) Alteration of the landscape, such as in landslide or major flood; and
  - (3) Environmental contamination by chemical or pollutants.

b. **Social Effects:**

- (1) Stress and psychological trauma;
- (2) Focus on the short term, foregoing long-term goals and opportunities;
- (3) Delay of programs that serve on long-standing social needs; and
- (4) Gaps in community economic classes tend to widen.

c. **Economic Effects:**

- (1) Loss of business;
- (2) Loss of jobs; and
- (3) Reduced cash flow within the community.

1.20.1	<p><b>Training:</b> Ideally, REACs will conduct a minimum of one exercise a year. The exercise should vary in scope and duration, although the main focus should always be centered on supporting municipalities and LSDs.</p> <p><b>Recall Exercise:</b> Using the REAC fan-out, REMCs will initiate a recall twice a year. Alternatively, during REAC meetings, the fan-out list can be confirmed by individual departments / NGOs.</p> <p><b>Tabletop Exercise:</b> Tabletop exercises are inexpensive and are easy to conduct. Every effort should be made to conduct a quick tabletop exercise at the end of every REAC meeting. **Critical Infrastructure (CI)**

CI is defined as those physical and information technology facilities, networks, services and assets, which, if disrupted or destroyed, would have a serious impact on the health, safety, security or economic well-being of New Brunswickers or the effective functioning of government. CI impacts that require an immediate assessment in accordance with the recommended Activation Timeline.

**LOW:** Potential, imminent or actual threats, vulnerabilities or incidents. Active Monitoring is mandatory.

**MEDIUM:** Potential, imminent or actual threats, vulnerabilities or incidents assessed as limited in scope but having possible impacts on critical infrastructure. Mandatory monitoring is required. An escalation in REAC Activation will likely be necessary.

**HIGH:** Potential, imminent or actual threats, vulnerabilities or incidents where precautions and actions are required immediately.
